A RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO BLESSED ST. JOHN PHARMACEUTICAL AND GENERAL MERCHANDISE FOR THE PROCUREMENT OF INVESTIGATION TOOLS AND MATERIALS.

WHEREAS, pursuant to RA 9184, in order to facilitate professionalization and harmonization standards of procurement, the Bids and Awards Committee, Bureau of Fire Protection-Cordillera Administrative Region (BAC BFP-CAR) was reconstituted by virtue of Regional Order Number COM-2021-04;

WHEREAS, BFP-CAR through its approved complete staff work dated 08 February 2021 and Certification of Availability of Funds (CAF) dated April 07, 2021, an Approved Budget for the Contract (ABC) amounting to Three Hundred Five Thousand Two Hundred Pesos and Eighty Centavos (Php 305, 200.80), relative to the procurement of investigation tools and materials was allotted;

WHEREAS, Request for Quotation Forms (RFQ) were sent to three (3) prospective suppliers of known qualifications for the above procurement namely Micel Marketing, JLC Pharma Distributor, and Blessed St., John Pharmaceutical and General Merchandise;

WHEREAS, before the lapse of the deadline for the submission of quotation at 0900H 26 April 2021, only Blessed St., John Pharmaceutical and General Merchandise submitted its quotation amounting to Three Hundred Four Thousand Two Hundred Thirty Pesos (Php 304,230.00);

WHEREAS, upon careful review and evaluation of the Technical Working Group (TWG) on the legal requirements submitted by Blessed St., John Pharmaceutical and General Merchandise, it was found to be compliant with the eligibility requirements as evidenced by the submission of its valid Mayor's Permit, PhilGEPS Registration number and Omnibus Sworn Statement;

WHEREAS, upon evaluation, the TWG likewise determined that the quote proposal submitted by Blessed St., John Pharmaceutical and General Merchandise in the amount of Three Hundred Four Thousand Two Hundred Thirty Pesos (Php 304,230.00) is the Single Calculated Quotation;

WHEREAS, the TWG proceeded with the evaluation of the quotation vis-à-vis with the technical requirements of the procurement and has been found to be compliant, legally, financially and technically capable for this procurement and thus, being recommended to be declared as the Single Calculated and Responsive Quotation for consideration of award of contract;

WHEREAS, Section 37 of the Implementing Rules and Regulations of RA 9184 mandates that the BAC shall recommend the award of the contract to the Head of the Procuring Entity or his/her duly authorized representative;

NOW, THEREFORE WE, the members of the Bids and Awards Committee, by virtue of the powers vested in us by law, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HoPE, for her consideration and approval, to award the contract to Blessed St., John Pharmaceutical and General Merchandise in the amount of Three Hundred Four Thousand Two Hundred Thirty Pesos (Php 304,230.00);

This resolution shall take effect immediately.
