**RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE
AWARD OF CONTRACT TO POOTEN FAMILY CORPORATION RE: LEASE OF
VENUE FOR THE CONDUCT OF BASIC RESCUE TECHNIQUE COURSE (BRTC)**

WHEREAS, pursuant to RA 9184, in order to facilitate professionalization and harmonization standards of procurement, the Bids and Awards Committee, Bureau of Fire Protection-Cordillera Administrative Region (BAC BFP-CAR) was reconstituted by virtue of Regional Order Number COM-2021-10 dated 05 May 2021;

WHEREAS, BFP-CAR through its approved completed staff work dated 22 March 2021 and Certification as to Availability of Funds (CAF) dated April 12, 2021 allotted an Approved Budget for the Contract (ABC) amounting to Five Hundred Eighty Thousand Five Hundred Sixty Pesos (Php 580,560.00), relative to the conduct of Basic Rescue Technique Course (BRTC).

WHEREAS, Request for Quotation (RFQ) forms were sent to three (3) prospective suppliers of known qualifications for the above procurement on May 06, 2021 namely: Bredco Resort, Sulfuric Hot Spring, and Pooten Family Corporation;

WHEREAS, before the lapse of the deadline for the submission of quotation at 1000H 14 May 2021, only Pooten Family Corporation submitted its quotation amounting to Five Hundred Seventy-Eight Thousand Four Hundred Seventy Pesos (Php 578,470.00);

WHEREAS, upon careful review and evaluation of the Technical Working Group (TWG) on the legal requirements submitted by Pooten Family Corporation, it was found to be compliant with the eligibility requirements as evidenced by the submission of its valid Mayor's Permit, PhilGEPS Registration Number and Income Tax Return;

WHEREAS, upon quote evaluation, the TWG likewise determined that the financial proposal submitted by Pooten Family Corporation in the amount of Five Hundred Seventy-Eight Thousand Four Hundred Seventy Pesos (Php 578,470.00) is the Single Calculated Quotation;


WHEREAS, the TWG proceeded with the evaluation of the quotation vis-à-vis with the technical requirements of the procurement and has been found to be compliant, legally, financially and technically capable for this procurement and thus, being recommended to be declared as the Single Calculated and Responsive Quotation for the consideration of award of contract;

WHEREAS, Section 37 of the Implementing Rules and Regulations of RA 9184 mandates that the BAC shall recommend the award of the contract to the Head of the Procuring Entity or his/her duly authorized representative;

NOW, THEREFORE WE, the Members of the Bids and Awards Committee, by virtue of the powers vested by law, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HoPE, for her consideration and approval, the award of the contract to Pooten Family Corporation in the amount of Five Hundred Seventy-Eight Thousand Four Hundred Seventy Pesos (Php 578,470.00) for the lease of venue re: conduct of basic rescue technique course (BRTC).


This resolution shall take effect immediately.
