5. One (1) Authenticated copy of Transcript Of Records (TOR) and College Diploma duly authenticated by the school registrar;
6. One (1) Authenticated copy of Second Level Eligibility/Board Rating (RA1080, PD 907 (Honor Graduate), CS Professional, CS Fire Officer Exam and License duly authenticated by the issuing agency (PRC/CSC/MARINA, etc.);
7. Original PSA Copy of Birth Certificate;
8. Original PSA Copy of Marriage Certificate (if applicable);
9. Original Copy of Barangay, Mayor's, Municipal Trial Court, Regional Trial Court, Police, and National Bureau of Investigation Clearances (should be valid until 01 July 2022);
